#### **PUBLIC HEARING(S)**

PETITION NO. 2014ZTA-0001 (Definition – General Stores) Presented by Camilla Moore, Director of Planning & Zoning

Article II, Section 2.3 currently does not define General Stores. Staff recommends adding a definition of "General Store" to ensure that such uses which fall under this category be properly placed. This definition will help clarify and define the difference between general stores, grocery stores, and convenience stores, which sell general merchandise and food. Such clarifications will allow Staff to more easily make a determination concerning whether a proposed use is permitted or not. Therefore, there needs to be a clear distinction between such uses so that the general public fully understands the difference.

Mayor Dixon opened the floor for the public hearing.

# **Council Member Kenny Ruffin, Ward 4**

Southern Regional is a vital institution in our community, and we value having a hospital in the area. Southern Regional Medical Center officials have asked Clayton County Board of Commissioners for financial assistance to help keep the hospital open. In doing so, requires assistance from the City of Riverdale.

Free patient care provided to patients who come to Southern Regional Hospital without an ability to pay has caused the hospital to struggle to meet its financial obligations. In 2013, nearly 80% of the "charity care" services provided to patients where Clayton County residents.
