





RESOLUTION NO. 32-03-2015

A RESOLUTION OF THE MAYOR & CITY COUNCIL OF THE CITY OF RIVERDALE, GEORGIA ENDING SHERRY D. HENDERSON TERM AS INTERIM CITY CLERK AND APPOINTING SYLVIA VAUGHN AS CITY CLERK; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE;

WHEREAS, the City of Riverdale (“City”) operates under a Council-Manager form of government, as set forth in the Riverdale City Charter; and

WHEREAS, the Riverdale City Charter authorizes the Mayor and City Council to appoint city officers as deemed necessary for the efficient operation of city government, City Clerk shall be appointed by the City Council and shall serve at the pleasure of the Mayor & City Council; and

WHEREAS, each officer appointed shall take such oath, perform such duties as prescribed in the job descriptions adopted by Riverdale Mayor and City Council; and

WHEREAS, the City Council appoints Sylvia Vaughn as City Clerk to handle the affairs of the Office of The City Clerk, and shall be responsible for carrying out the responsibilities of City Clerk until such time as directed otherwise; and

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF RIVERDALE, GEORGIA DOES HEREBY RESOLVE:

Section 1. Recitals. The foregoing recitals are true and correct and made a part of this Resolution.

Section 2. Appointment. The City Council hereby appoints Sylvia Vaughn as the City Clerk.

Section 3. Filing Copies. A copy of the final document will be kept on file in the Office of the City Clerk.

Section 4. Severability Clause. If any section, part or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other provision of this Resolution, and all sections, parts and provisions of this Resolution shall be severable.

Section 5. Effective Date. Mayor & Council will provide an effective date.
