RESOLUTION NO. 18-9-2020

WHEREAS, the Mayor and Council for the City of Riverdale ("City") contracts with Republic Services of Georgia ("Republic") to provide trash service to residential and commercial citizens within the City; and

WHEREAS, the contract with Republic expires on December 31, 2020; and

WHEREAS, the City and State has declared a state of emergency based on the COVID-19 global pandemic; and

WHEREAS, given the pandemic, the City is operating in a limited capacity; and

WHEREAS, there is an immediate need to continue the trash services with Republic beyond the expiration date and so long as the pandemic and local state of emergency continues; and

WHEREAS, given the limited operation of the City government, it is in the best interest of the City and its citizens to renew said contract with Republic for one year beginning January 1, 2021 (Contract Renewal attached hereto and incorporated by reference at **EXHIBIT "A"**); and

WHEREAS, the new expiration date is December 31, 2021; and

WHEREAS, the new rates for this renewal period shall be effective on July 1, 2021 to allow notice to customers and new rates are reflected in the attached Contract Renewal; and

WHEREAS, the City reserves the right at the end of the one-year renewal period to either extend for a further term or terminate the contract.

NOW THEREFORE IT IS HEREBY RESOLVED that the City hereby renews its current contract with BFI WASTE SERVICES, LLC d/b/a Republic Services of Georgia for a period of one year beginning January 1, 2021.

SO RESOLVED, this 14th day of September, 2020.

EXHIBIT "A"

Contract Renewal

IT IS HEREBY AGREED AS FOLLOWS:

3.2 Sanitation Services

1. Contract Term- The Renewal Term of service will begin on January 1, 2021 for a period of one year ending December 31, 2021 with renewal options pending agreement of both parties. The City and Contractor shall have the right to extend the contract for an additional (6) six-month term pending agreement of both parties. The City may notify in writing at least sixty (60) days prior to the expiration of this renewal term of the City's decision to renew. Otherwise, this renewal **will** terminate on December 31, 2021.

2. Services-Effective July 1, 2021- The following rates will be effective during the Renewal Term:
Residential collection service \$14.37 per unit
Commercial 4% rate increase adjustment- Exhibit "A"
Industrial 4% rate increase adjustment- Exhibit "A"
