**WHEREAS**, the Mayor and Council are the governing body of the City of Riverdale, Georgia ("City");

**WHEREAS**, the Mayor and Council is tasked with protecting and promoting the health, safety, morals and welfare of the citizens of the City; and

**WHEREAS**, the Mayor and Council is also tasked with protecting financial integrity of the City; and

**WHEREAS**, the City desires to implement a refunding of the City of Riverdale's Town Center Improvement Project Revenue Bonds; and

**WHEREAS**, the City has determined that it is necessary to proceed with the refunding as one method to reduce costs; and

**WHEREAS**, the staff has sought qualified underwriters to assist in the refunding and has determined that Stephens Inc., a municipal underwriter is the most qualified underwriter for the refunding process; and

**WHEREAS**, the Mayor and Council desires to authorize the City Manager to execute the necessary agreements with Stephens, Inc. for the development and implementation of a refunding for the revenue bonds, series 2010A; and

**BE IT HEREBY RESOLVED**, by a majority vote of the Mayor and Council of the City of Riverdale that the City Manager is authorized to enter into an agreement with Stephens, Inc. to develop and implement the refunding of the City of Riverdale Town Center Improvement Projects Revenue Bonds, Series 2010A..






